## **Parke County Economic Plan**

Parke County Redevelopment Commission adopted this plan in April 2019.

As Parke County leaders worked on this plan to attract economic development opportunities, they paid close attention to state-wide trends related to where employers chose to expand or locate. In particular, today's businesses are choosing locations where they have the best opportunity to attract a large workforce. This means businesses are choosing to locate in settings that have an outstanding quality of life that attracts the workforce they need.

The good news for Parke County is that the same things that make it attractive to millions of visitors every year, also make it an attractive place to live. Even more, investments to improve quality of life not only make the county more appealing to residents, but will attract more visitors. This plan recommends investments in trails, local parks and downtown districts to improve quality of life and expand tourism opportunities.

While investments in quality of life are important, Parke County also needs to take additional steps to capture the opportunities created by the investment. Namely, this plan recommends creating shovel ready development sites, actions to improve the capture of tourism spending, and implementation of broadband infrastructure. Together, these investments will position Parke County for a bright future.

## **Broadband Readiness Committee Update**

The Broadband Committee of Parke County has set several goals to accomplish and we are well on our way. We would like to provide an update to you on where we are currently on our journey. While we have had a lot of positive input and support, there are several roadblocks preventing us from moving forward and achieving our top priority goal – providing robust and reliable internet service to all residents and businesses in Parke County. Please see the outline of our successes, current challenges and plans for moving forward.

#### **Successes:**

- Applied and became the second county in the state to be deemed Broadband Ready Certified
- Created an active and sustainable Parke County Broadband Readiness Committee
- Successfully deployed a survey by Vantage Point Solutions and completed a Broadband Readiness Feasibility Study
- Identified areas that need coverage with the assistance of residents and providers to truly understand where service is lacking
- Received support by local officials to move forward with the Broadband Readiness initiative which
  included centralizing permitting, waiving permitting fees, and creating an Infrastructure Development
  Zone for broadband, as well as exempting local personal property taxation for broadband projects

## **Challenges:**

- Large majority of our county does not have access to reliable internet connection
  - Current FCC 477 does not accurately reflect service provided in our county. This has limited our ability to find a partner provider willing to apply for the Indiana Next Level Connection for Broadband or other funding programs
- Over 70% of the population in Parke County lives outside of incorporated towns
- The population density averages 6 homes per mile (using average meter counts or rural utility provider)
- Provide ROI is not attainable during the construction phase of this project
- Searching for a provider willing to serve all addresses within previously funded census blocks that are not currently served

#### Plan for Overcoming Challenges:

- Continue to engage in direct dialogue with potential providers
- Prepare for future rounds of potential government funding
- Attend the West Central Indiana Broadband Summit

We continue to meet with providers to discuss option, pilot programs, and opportunities in Parke County.

## "Powering Rural - The Heartland Tour" Held in August

A panel of representatives from Federal, State, and Local government agencies all focused on supporting economic development in rural areas of Indiana were available for an interactive discussion with attendees to describe the resources available from their agencies, the ways they might be employed to support economic activity and how they have teamed up with one another to support entrepreneurs and communities across Indiana. This was an opportunity to provide connections to people and resources that may make a positive impact in West Central Indiana.
